1. Personal data collected

2. Use of personal data

To send you email periodically - By accepting this Privacy Policy, the user expressly authorizes Albuar Villas to use their data to keep you updated about our products and services, contests, promotions, awards and events, as well as for sending occasional advertising (pursuant to Article 22 of Decree-Law No. 7/2004 of 7 January, as amended by Decree-Law No. 62/2009, of 10 March), relating to products and services offered by us or partners selected from Albuar Villas.

Note: The user of the website or customer is free to refuse these submissions at any time, using the specific link for this purpose, present in all communications of an advertising nature that Albuar Villas sends him.

3. Data Protection

4. Cookies and other data collection technologies

Albuar Villas may use Cookies and pixel tags in its services, emails and advertisements. A 'Cookie' is a small

text file, automatically saved by the user's computer, and which allows its identification to always use Albuar Villas again. Albuar Villas users are free to configure their Internet browser in order to prevent the installation of 'Cookies' on their computer, if they so wish. Cookies act as identifiers for your computer but not for you personally.

We use Cookies to understand and save your preferences for future visits, to control the advertisements displayed, to compile statistical data on traffic to Albuar Villas and on the use of the website so that we can improve the experience of our users and our services in the future. The pixel tag, also known as transparent GIF or web beacon, is an invisible graphic file, placed on certain pages of a website or email, but not on your computer. Pixel tags normally work in conjunction with Cookies, registering when a specific computer accesses a page on a website. If you have turned off Cookies on your Internet browser, the pixel tag only reports an anonymous visit.
